A RESOLUTION OF THE MUSKEGON CHAPTER OF THE DAUGHTERS OF THE AMERICAN REVOLUTION

ESTABLISHING THE MUSKEGON COUNTY AMERICA250MI (SEMIQUINCENTENNIAL) COMMITTEE

WHEREAS, we acknowledge that we are on the ancestral and unceded territory of the Anishinaabek, the People of the Three Fires, the Ojibwe, the Odawa and the Potawatomi. We honor and respect them for the connection to their land since time immemorial; and

WHEREAS, the United States of America will commemorate the 250th anniversary of the Declaration of Independence in 2026; and

WHEREAS, Michigan's communities and people have made extraordinary contributions to the American story—through civic leadership, service, innovation, culture, and a continuing commitment to democratic ideals; and

WHEREAS, America250MI is Michigan's official committee for the United States Semiquincentennial, led in partnership by the Historical Society of Michigan and the Michigan History Center, to encourage public engagement and inclusive storytelling across all 83 counties; and

WHEREAS, the 5 Guiding Themes of Unfinished Revolutions, We the People, Power of Place, American Experiment, and Doing History, will serve as guideposts for [insert organization name] to utilize its best practices and resources to embrace America250MI core values.

WHEREAS, THE MUSKEGON CHAPTER OF THE DAUGHTERS OF THE AMERICAN REVOLUTION recognizes this commemoration as an opportunity to strengthen community connection, support education and civic participation, and elevate the full diversity of our shared history, including the histories of Tribal Nations and historically underrepresented communities; and

WHEREAS, THE MUSKEGON CHAPTER OF THE DAUGHTERS OF THE AMERICAN REVOLUTION desires to formally participate in America250MI as an officially recognized local committee and coordinating partner, and to align local planning with America250MI guidelines and statewide goals; and

NOW, THEREFORE, BE IT RESOLVED, that THE MUSKEGON CHAPTER OF THE DAUGHTERS OF THE AMERICAN REVOLUTION America250MI Semiquincentennial Committee (“Local Committee”) to plan, coordinate, and support programs, projects, and events related to the commemoration of America’s 250th anniversary; and

BE IT FURTHER RESOLVED, that the Local Committee will:

1. Encourage broad, inclusive community participation and partnerships, welcoming residents of all backgrounds, ages, and experiences;
2. Coordinate and promote local Semiquincentennial activities, including educational and civic opportunities aligned with America250MI’s five guiding themes;
3. Communicate regularly with America250MI and submit relevant programs, projects, and events through official America250MI channels (including the America250MI website/community calendar, as applicable);
4. Follow America250MI branding and planning guidelines and any applicable America250 Foundation guidance; and
5. Maintain appropriate transparency and accountability practices for committee operations, volunteers, and community partnerships.

BE IT FURTHER RESOLVED, that THE MUSKEGON CHAPTER OF THE DAUGHTERS OF THE AMERICAN REVOLUTION authorizes Bonnie J. Krueger, Chapter Regent and Cindy C. Brady, Chapter Chair, DAR America 250 Committee to take reasonable steps to implement this resolution and support the Local Committee’s formation, including convening an initial organizational meeting.




